INITIAL CONTACT

Call Myers Weinberg and identify yourself as a member of CUPE in Manitoba. You will be asked to provide a few details ensuring your eligibility in the Legal Care Plan, as well as some information with reference to the nature

of your problem. Once your eligibility is confirmed, you will be referred to a lawyer who practices in the area of law for which legal assistance is required. Please note, within Manitoba, collect calls are accepted.

COVERAGE

Roadside assistance is available through our central toll-free number on a "sign and drive" basis, or should the member prefer to use his or her own service provider, DAA will reimburse up to \$25 per service call. If the service provider cannot make the member's vehicle safely operational at the site of a mechanical breakdown, DAA will reimburse towing costs up to \$100 per call.

Fuel Delivery A supply of fuel will be delivered to the member to enable the member to reach the nearest available service station. The member will be responsible for the cost of the fuel.

Battery Boosts or Cold Weather Starting A service provider will attempt to start the member's vehicle.

Tire Changes A service provider will install the member's inflated and usable spare tire. In the event the spare tire is unusable, the vehicle will be towed to the nearest, appropriate repair facility. Service providers do not repair tires on site.

Lockout Services Should a member lock his or her keys in a vehicle, a service provider will attempt to open the vehicle. Parts, excessive labour and/or services of a locksmith may be at the member's expense.

Mechanical First Aid Minor adjustments or repairs will be made to render the member's vehicle safely operational.

Winching/Extrication A Dominion Elite member is entitled to one (1) truck for one (1) hour to have his or her vehicle extricated from mud, snow or ditch.

Towing Should a member's vehicle not be fit to operate safely under its own power following a mechanical breakdown, it will be towed to the nearest, appropriate repair facility within 200km.

Traffic Accident Benefits Should a member's vehicle become disabled due to a traffic accident, expenses incurred within 72 hours of the incident must be submitted to DAA within 30 days. A police report must accompany the claim for reimbursement of towing, emergency transportation, car rental and emergency accommodations. Maximum benefits are \$200 per category. In addition, DAA will reimburse up to \$200 of the member's out-of-pocket expenses for return to repair site transportation, and should the member be hospitalized, special return of passengers. Also, if ambulance services are required following the accident, the member as driver or passenger and the member's fellow passengers may be reimbursed 100% of ambulance costs not covered by any provincial health plan or automobile insurance company.

Mechanical Breakdown Benefits Should a Dominion Elite member's vehicle become inoperable due to a mechanical breakdown more than 80km from home, DAA will reimburse up to \$100 (per membership year) for each of the following out-of-pocket expenses incurred within 72 hours of the breakdown:

- accommodation (including meals)
car rental or taxi fare
transportation
return to repair site transportation
- special return of passengers

Original receipts must be submitted along with proof of breakdown (i.e., repair invoice) to DAA within 30 days of the incident for consideration for reimbursement.

Hazardous Weather Benefits Should a member experience delays and/or expenses due to snow, hail, ice, flood, tornado, hurricane, fog, avalanche or forest fire more than 80km from home, benefits will be reimbursed for personal rescue, emergency accommodation, meals, emergency communications, personal necessities and essential non-medical expenses. Benefits are paid at 75% of actual expenses incurred, to a maximum combined total of \$250.00 per membership year. Proof must be submitted that roads were impassable, such as police report, government report or newspaper clipping describing the circumstances.

Fire, Theft and Vandalism Benefits Should a member's car be stolen or damaged to the point of being inoperable by fire or vandalism, DAA will reimburse up to \$100 per category for car rental, transportation and accommodations (including meals) per membership year.

Pedestrian Legal Benefit Should an Elite member, as a pedestrian, be involved in a traffic accident, DAA will reimburse up to \$250 for legal fees, should the member be sued in a civil court for damages or should the member need to file suit in a civil court to obtain compensation for injuries from the responsible party.

Legal Benefits Our comprehensive legal benefits provide reimbursement for legal defence and appeals against conviction for criminal negligence in a motor vehicle, motor vehicle damage suits, charges of dangerous or careless driving, Highway Traffic Act charges and moving violation charges under a municipal by-law. 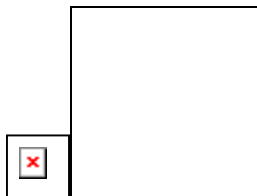

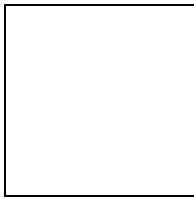
